## 6 Payment and Cancellation Policy

- **Published cost(space only)- US \$47.50 per sq. ft.**
- **Avail Early Bird Discount of 7.5% on bookings done before 24<sup>th</sup> Feb 2023.**
- 35% on booking
- 35% before 24<sup>th</sup> February, 2023
- 30% before 30<sup>th</sup> June, 2023
- 100% payment to be received by 30th June, 2023
- Application for registration once received will be considered as confirmed participation.
- AIPMA reserves the authority to allocate the space/ stall to other participants in case of non-payment.
- Participation once confirmed cannot be cancelled.
- In case of non-payment, AIPMA reserve the right to release the reserved space/ stall. The advance payment already made towards the event shall not be refunded to the participant.
- No refund shall be made to the participant on cancellation of registration.
- Cancellation of participation charges shall not be adjusted for any other event or activities organized by AIPMA.
- If the event is cancelled by the event organizer, the organizer reserves the right to final decision on refund/ carry forward of the participation charges and AIPMA shall abide by the organizer's decision on the same.
- If the organizer decides to refund the participation charges in the event of cancellation, the participant shall receive the same once the organizer refunds the money back to AIPMA in full.

## 7 Disclaimer

- Selection of participants will be done on first-cum-first-served basis.
- AIPMA would make allocation of available space in the show premises at its discretion and its decision in this regard shall be final and binding on all.
- The space allotted to the approved participants is to be used exclusively by them for display of their exhibits as approved by AIPMA. Sub-letting of space is not permissible. Violation of this clause may lead to cancellation of space allotted, forfeiting of space rent, cancellation of government grant and debarring of such participants from future participation in AIPMA's events.
- Visa Assistance shall be provided to only Indian nationals who are regular employee/ director/partner/proprietor of the participating company. Assistance shall not be available to exporters of foreign nationality or those holding foreign passports.
- Since AIPMA, on behalf of the participating company, has already committed for certain financial bindings by booking of space, construction of stand, catalogue entry, general publicity support, etc, no refund shall be made to the participants on account of denial of visa/ delay in receipt of visa.
- Only goods of Indian origin will be allowed for display in the India Pavilion.
- Exhibits of participants whose representatives do not turn up at the event will not be displayed.
- AIPMA will not be responsible for any shipment of exhibits for display and clearance of samples/goods at the customs.
- Participants shall make their own arrangements for removing exhibits from the packing case and displaying them in the booth.

## 9 General Terms & Conditions

- Application should be duly signed, stamped and authorized. In case the application is not signed/ stamped/ authorized, the submitted application shall still be considered as official confirmation of participation.
- Only applications submitted with payment shall be considered for confirmation of event participation.
- Any revision in the applied area shall be subject to the approval of AIPMA.
- Additional services, other than those specified in the event manual, shall be charged as per the actual cost or as levied by the event organizers/ third-party
- With respect to any fluctuation in foreign exchange rates or any other service charges, no refunds shall be made by AIPMA/ event organizers against the charges previously paid by the participant towards the event.
- AIPMA does not hold any financial or legal bindings on the products or services exhibited during the event. The participants are solely responsible for all financial and legal bindings related to their products/ services promoted and showcased during the event.
