The Association has, as on date posted at www.aipma.net and sent by email to members whose email IDs are registered with the Association, the Notice convening 80th Annual General Meeting (AGM) of the Association on **Saturday, the 26th of September, 2026 at 5.00 pm** in the **Hotel Taj Santacruz**, Near Domestic Terminal, Chhatrapati Shivaji Maharaj International Airport, Off Western Express Highway, Santacruz (East), Mumbai - 400099, to consider and transact business pursuant to the clause No.11(c) page 16 & 17 of Memorandum & Articles of Association as amended on 15th September, 2015 and Companies (Management and Administration) Amendment Rules, 2015, along with Statement of accounts as on 31.03.2026, and instructions for e-voting.

Shri Niranjn Sheth (Membership No.LA1W-00378) has been appointed as "Scrutinizer", to monitor and scrutinize the e-voting process on the proposed Agenda in a fair and transparent manner.

The facility for physical voting on the date of the 80th AGM shall be made available to members.

The e-voting period commences from **Wednesday, the 23rd September, 2026 9:00 am (IST) and ends on Friday, the 25th September, 2026 5:00 pm (IST)**. During the e-voting period, members of AIPMA may cast their votes electronically. The e-voting module shall be disabled by M/s. Right2Vote Infotech Pvt. Ltd., for voting thereafter. Once the vote on Agenda is cast by the member, the member shall not be allowed to change it subsequently or cast vote again. Members attending the meeting who have not already cast their vote by remote e-voting shall be able to exercise their right on the date of the AGM through physical ballot between 10.00 am upto 4.00 pm. The members who have cast their vote by remote e-voting prior to the meeting may also attend the meeting but shall not be entitled to cast their vote again. Members as on the cut-off date i.e. **Saturday, the 19th September, 2026** shall be entitled to vote physically on the date of the 80th AGM upto 4.00 pm.
